**ORDER No. 4001**

On the basis of the merit list of candidates qualified in the recruitment examination (2009) for appointment to the post of Lower Grade Clerk received from the Staff Selection Commission, New Delhi and consequent on acceptance of the terms and conditions incorporated in the 'offer of Appointment' communicated to them individually vide Administration's Memorandum No. 47-1(1)/2008-PW Vol-VII dated 01.10.2010, the Secretary (Personnel), A & N Administration is pleased to order the appointment on temporary basis of the 255 (Two hundred fifty five) candidates mentioned in the annexure attached to this order as **Lower Grade Clerk** in the amalgamated Clerical Cadre of A & N Administration, on a initial Pay of Rs.5830 plus Grade Pay of Rs. 1900 per month in the pay scale in PB-I of Rs.5200-20200 +Grade Pay Rs. 1900 subject to the following terms and conditions with effect from the date of their reporting for duty at their respective places/offices of postings as shown against their names:-

1. He/She shall produce certificate of fitness issued by the Competent Medical Authority establishing his/her suitability for Govt. Service;
2. He/she shall take an oath of allegiance to the Constitution of India or make solemn affirmation to that effect in the prescribed form;
3. He/She shall be required to submit a declaration, in the prescribed form regarding his/her marital status and in the event of his/her having more than one spouse living or having a spouse living marries in any case in which such marriage is void by reason of its taking place during the life time of such spouse subject to his/her being exempted from the operation of the requirement in this behalf;
4. His/her being found suitable for Govt. Service after verification of his/her character and antecedents through Police/ District Magistrate;
5. He/She may be required to serve in any part of Andaman and Nicobar Islands as well as on the mainland where offices of the Andaman and Nicobar Administration are located;
6. In addition to the Pay plus Grade Pay mentioned above, he/she will be entitled to Dearness Allowance, Special Compensatory Allowance, Hard Area Allowance and House Rent Allowance as admissible to employees of similar categories working under the Andaman and Nicobar Administration;
7. He/She shall be on probation for a period of two years from the date of the appointment. The period of probation is liable to be extended at the discretion of the Secretary (Personnel), Andaman and Nicobar Administration;

8. His/her services are liable to be terminated at any time during the period of probation, after giving one month notice, if his/her work and conduct during the period of probation are found to be unsatisfactory;
9. His/her seniority shall be determined in the order of merit in accordance with the instructions/ guidelines issued by the Govt. of India on the subject from time to time;
10. Since Computer Education is a desirable qualification for the post, he/she shall qualify a test in computer typing with a speed not less 5000 keys-depressions per hour, which will be conducted by the Administration with the assistance of NIC, Secretariat Complex within the probation period;
11. If any declaration given or information furnished by him/her is proved to be false or if he/she is found to have willfully suppressed any material information that would have rendered him/her unsuitable for Government employment, he/she will be liable to be removed from service, apart from any other action under the relevant rules/instructions that may be taken against him/her;
12. He/She shall be governed by the New Pension Scheme, 2004 as per Govt. of India's decision/orders issued from time to time in this regard;
13. In respect of matters not specified above, his/her services shall be governed by the relevant rules and orders applicable to employees of similar categories working under the Andaman and Nicobar Administration;
14. The candidates are directed to report for duty to their respective place of posting **within 30 days** from the date of issue of this order, failing which their appointment will be treated as cancelled;
15. No TA/DA will be admissible or allowed for his/her joining the post on appointment;
16. He/she shall produce 'Admit card' (half portion), Original Certificates in proof of Date of birth, Educational Qualifications, Category certificate etc before the respective office of his/her posting at the time of reporting for duty for verification.
