

NOTIFICATION

No..... F. No. 4-246 / DSW / UEA / 2005-06 / Vol-II. In exercise of powers vested in him under section-68 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act 1995 read with notification No. U-11030 / 3 / 96 - UTL dated 05.12.1997 issued by the Govt. of India, Ministry of Home Affairs, New Delhi and in reference to the letter bearing No. 3-2 (CEC) / CCD / 2006 / 434 dated 30.06.2006 received from the Ministry of Social Justice and Empowerment, New Delhi, the Lt. Governor (Administrator), Andaman and Nicobar Islands is hereby pleased to merge the Schemes "Providing Financial Assistance to the Physically Handicapped Unemployed Persons" and "Providing Financial Allowances to the Permanently Disabled Persons" w.e.f 1st October 2010 in order to extend uniform package of assistance to all categories of eligible persons with disabilities of Andaman and Nicobar Islands. The new scheme will be implemented w.e.f 1st Oct. 2010 subject to the following conditions:

1) Short title and commencement:

- i) This scheme may be called 'The Andaman and Nicobar Islands Disability Allowances Scheme' 2010.
- ii) This scheme will be implemented in the UT of Andaman and Nicobar Islands by the Directorate of Social Welfare.
- iii) It shall come into force from 1st Oct. 2010

2) The definition of disability is as per the definition in Persons with Disability Act 1995, and the National Trust for the Welfare of Persons with Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities Act, 1999 (National Trust Act 1999) revised from time to time and any other guidelines issued by the Ministry of Social Justice and Empowerment, Govt. of India in this regard.

3) Definition of Household : Household means Parents, Husband/Wife and dependant children.

4) Eligibility:

- i) Persons who are permanent residents of the Union Territory of Andaman and Nicobar Islands or are domiciled and have resided in the Union Territory of Andaman and Nicobar Islands for more than 10 years at the time of making the application. A certificate in this respect is to be obtained from Revenue Authority.
- ii) Any unemployed person of age 18 yrs or more, having 40% and above disability, with household income of less than Rs. 2.5 lakhs per annum, is eligible for the financial assistance.
