





1. The selected beneficiary is eligible to purchase Marine Inboard engine from the local authorized dealer having facility for after sales service and maintenance.
2. The subsidy amount will be released to the beneficiary directly on purchase of the marine inboard engine by remitting the full cost to the supplier. 9. The Department of Fisheries through its Zonal Officer In-charges/ station In-charges will conduct periodic inspection to ensure proper utilization of the asset by the beneficiaries.
