Invitation of the application for appointment of Chairperson on Forum for redressal of grievances of consumers in the UT of A & N Islands in terms of Joint Electricity Regulatory Commission (Establishment of Forum for redressal of grievances of consumers), Regulation, 2009.

The retired Official so appointed as Chairperson shall be treated as if on re-employment on the last pay Applicable to him/her at the time of retirement under the rules.

The application giving the following data and accompanied by attested copies of the supporting documents/testimonials and two references from responsible persons of the area, must reach to the Secretary(Power), A & N Administration, Secretariat, Port Blair by 5/1/2010.

- v) Educational Qualification(Starting from Matriculation/ Higher secondary)



- vi) Service to which applicant belonged prior to retirement.
- vii) Date of initial appointment and the post.
- viii) Designation of last post held with date of retirement.
- ix) Pay scale and last pay drawn at the time of retirement.
- x) Details of the posts held during the last 20 years before retirement, with place of posting and tenure of each posting.
- xi) Whether anything adverse during service career.
- xii) Language known, indicate the extend of knowledge – very good, can read only, can write only.
- xiii) Details of experience in consumers affair, if any.
- xiv) Two passport size photographs
- xv) Whether member of any NGO (with brief description on NGO)
- xvi) Address for communication
- xvii) Permanent residential address.
- xviii) Self Certification about correctness of information furnished.
