Candidates will not be allowed to sit in the Written Examination under any circumstance, if they are not in possession of admit card. Candidate who is not in receipt of admit card till 27.01.2009 is advised to submit application in person addressed to the Chief Judicial Magistrate, Port Blair (Chairman, Selection Committee) together with a Photograph of the similar type pasted on the application, from 27.01.2009 to 30.01.2009, so that duplicate admit card may be issued.
