NOTICE

2. Govt. Mohanpura Senior Secondary School, Port Blair (Roll No: 501 to 1000)
3. Jawaharlal Nehru Rajkeeya Mahavidyalaya, Port Blair (Roll No: 1001 to 2000)
4. Govt. Girls Senior Secondary School, Port Blair. (Roll No: 2001 to 2230)

Candidates will not be allowed to sit in the Written Examination under any circumstance, if they are not in possession of admit card. Candidates are advised to reach the venue of examination at-least 20 minutes before the commencement of examination.
