NOTICE

Admit Cards for written test for the post of Peon and Night-Guard/Chowkidar have been issued to all the eligible candidates after allotting respective roll numbers. The written examination shall be held on 08.02.2009 from 10.00 AM to 12.00 Noon in the following venues:-

A. Peon

1. Govt. Model Senior Secondary School, Port Blair (Roll No: 1 to 500)
2. Govt. Mohanpura Senior Secondary School, Port Blair (Roll No: 501 to 590)

B. Night Guard

1. Govt. Mohanpura Senior Secondary School, Port Blair

Candidates will not be allowed to sit in the Written Examination under any circumstance, if they are not in possession of admit card. Candidates are advised to reach the venue of examination at-least 20 minutes before the commencement of examination. Calculating devices of any type, cell phones etc, will not be allowed in the examination hall. Candidate who is not in receipt of admit card till 27.01.2009 is advised to submit application in person addressed to the Chief Judicial Magistrate, Port Blair (Chairman, Selection Committee) together with a Photograph of the similar type pasted on the application, from 27.01.2009 to 30.01.2009, so that duplicate admit card may be issued. Admit card will not be issued under any circumstance in the venue of examination.
