**NOTIFICATION**

No. F.No.11-3/2003/RD. In exercise of the powers conferred under Section 196 of A&N Islands (Municipal) Regulation, 1994, the Lt. Governor (Administrator), A&N Islands is pleased to constitute the District Planning Committee for the Districts of South Andaman and North & Middle Andaman as in the manner given below with immediate effect for carrying out the functions given in the said Regulation.

I. **South Andaman District (including Campbell Bay)**

DC, North & Middle Andaman, District officers-in-charge of the Developmental Departments and Pramukhs of Panchayat Samities in the District shall be special invitees of the committee.

**Terms of reference**

The Zilla Parishad and Municipal Council shall prepare draft development plan for five year plan and Annual Plan in coordination with the Govt. Deptts. and other agencies in the District for the development of the area under its jurisdiction. The procedures and the time schedule given in the A&N Islands Panchayat Administration Rules, 1997 and other circulars/instructions issued from time to time should be followed for preparation of the plans. The Chairperson of District Planning Committee shall forward the Development plan for the District as recommended by the committee to the Administrator.

The DPCs shall follow the A&N Islands (District Planning Committee conduct of meetings, quorum and procedures in regard to Transaction of Business) Rules, 2002 in conducting the meetings of the committee.

This notification supercedes the Notification No.1/96 dated 3.1.96 and Notification No.345 dated 1.12.2005.


