Feedback Ventures Private Limited (FVPL) is assisting Directorate of Tourism for the project development in Public Private Partnership (PPP).

PROJECT RATIONALE

Andaman & Nicobar has the potential to emerge as one of the world's most exotic and high-end holiday destinations for Eco-tourism and Adventure Tourism. The islands are strategically located and International yachts bound to Phuket, Malaysia and other eastern ports already have A&N islands on their itinerary. In order to tap this potential, A&N Administration intends to develop 50 berth fully equipped Marina and operate Mechanized Luxury Boats with all the facilities for board and travel.
