On the basis of the merit list of candidates qualified in the recruitment examination for the post of 'Accountant' received from the Staff Selection Commission, New Delhi, the Finance Secretary, Andaman and Nicobar Administration is pleased to order the appointment, on temporary basis, of the fifteen (15) candidates mentioned in the annexure attached to this order as '**Accountant**'(Group 'C' Ministerial, Non-Gazetted) in the Chief Pay & Accounts Organisation, A & N Administration, on an initial pay of Rs. 8560/- per month in the PB-1 pay band of Rs. 5200-20200 with grade pay Rs. 2800, subject to the following terms and conditions, with effect from the date of their reporting duty at their respective places/offices of posting as shown against their names:-

1. He/She should produce certificate of fitness issued by the competent Medical Authority establishing his/her suitability for Govt. service;
2. He/She shall take an oath of allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed form;
3. He/She shall be required to submit a declaration in the prescribed form regarding his/her marital status and in the event of his/her having more than one spouse living or having a spouse living, marries in any case in which such marriages is void by reason of its taking place during the life time of such spouse; subject to his being exempted from the operation of the requirement in this behalf;
4. His/Her being found suitable for Government service after verification of his/her character and antecedents through Police/District Magistrate;
5. He/She may be required to serve in any part of Andaman and Nicobar Islands as well as on the mainland where offices of the Andaman and Nicobar Administration are located.
6. In addition to the pay mentioned above, he/she will be entitled to Dearness Allowance, Special Compensatory Allowance, Hard Area Allowance , House Rent Allowance and Island special duty allowance as admissible to the employees of similar categories working under the Chief Pay & Accounts Organisation, Andaman and Nicobar Administration.
7. He/She shall be on probation for a period of two(02) years from the date of the appointment. The period of probation is liable to be extended at the discretion of the Finance Secretary, A & N Administration.
8. His/Her services are liable to be terminated at any time during the period of probation after giving one-month notice, if his/her work and conduct during the period of probation are found to be unsatisfactory.
9. Their seniority shall be determined in the order of merit in accordance with the instructions/ guidelines issued by the Govt. of India on the subject from time to time.
10. If any declaration given or information furnished by him/her is proved to be false or if he/she is found to have willfully suppressed any material information/facts that would have rendered him/her unsuitable for Government employment, he/she will be liable to be removed from service, apart from any other action under the relevant rules/instructions that may be taken against him/her.

11. He/She shall be governed by the New Pension Schemes, 2004 as per Govt. of India's decision/orders issued from time to time in this regard.
12. In respect of matters not specified above, his/her services shall be governed by the relevant rules and orders applicable to employees of similar categories working under the Chief Pay & Accounts Organisation, Andaman and Nicobar Administration.
13. No TA/DA will be admissible or allowed for his/her joining the post on appointment.
14. Their appointment is further subject to verification of the original certificates in proof of date of birth, educational qualifications, etc. which they should produce before joining for duty to their respective place of postings.
15. The appointment is provisional and is subject to the OBC certificates/ Tribe certificates being verified through the proper channels and if the verification reveals that claim to belong to OBC/Scheduled Tribe is false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.
16. On appointment to the post of 'Accountant', they will have to pass a 'Departmental Confirmatory Examination' (within the probation period) conducted by the Finance Secretary, A & N Administration within four consecutive chances. Those who do not qualify the Departmental Confirmatory Examination within the prescribed period are liable to be discharged from the Govt. service.
17. They are directed to report for duty to their respective place of posting **within 30 days** from the date of issue of this order, failing which their appointment will be treated as cancelled.


