**ORDER NO: 257**


On the recommendations of the Departmental Selection Committee meeting held on 15<sup>th</sup> October, 2009, the Secretary (Statistics), Andaman & Nicobar Administration is pleased to order for appointment of the following Scheduled Tribe candidates as Junior Investigator against the post reserved for ST on temporary basis in the Amalgamated Statistical Cadre of the Andaman & Nicobar Administration in the revised Pay Band -1 Rs.5200-20200 and Grade Pay of Rs.2400/- and other allowances as admissible to the employees of similar categories working under the Administration with effect from the date of their reporting duty at their respective place of postings as shown against their names in the Annexure to this order. Their initial pay in the above Pay Band shall be Rs.7510/- plus Grade Pay.

1. Shri. K. Abdul Rasheed
2. Shri Alwyn Richardson

Their appointment shall be subject to the following terms and conditions:

1. They should produce Certificate of fitness issued by the competent Medical Authority establishing their suitability for Govt. service.
2. They shall take an oath of allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed form.
3. They shall be required to submit a declaration in the prescribed form regarding their marital status and in the event of their having more than one spouse living or having a spouse living, marriage in any case in which such marriage is void by reason of its taking place during the life time of such spouse, subject to they being exempted from the operation of the requirement on this behalf.
4. They being found suitable for Govt. service after verification of their character and antecedents through Police/District Magistrate.
5. They shall require to serve in any part of Andaman and Nicobar Islands as well as on the mainland offices of the Andaman and Nicobar Administration if required.
6. They shall be on probation for a period of two years from the date of appointment. The period of probation is liable to be extended at the discretion of the appointing authority.
7. Their services are liable to be terminated at any time during the period of probation after giving one month notice, if their work and conduct during the period of probation are found to be unsatisfactory.


8. Their seniority shall be determined in accordance with the instructions/guidelines issued by the Govt. of India on the subject from time to time.
9. If any declaration or information furnished by them are proved to be false or if they found to have willfully suppressed any material information that would have rendered them unsuitable in Government employment, they will be liable to be removed from service, apart from any other action under the relevant rules/instructions that may be taken against them.
10. They shall be governed by New Pension Schemes, 2004 as per Govt. of India's decision/orders issued from time to time in this regard.
11. In respect of matters not specified above, their services shall be governed by the relevant rules and orders applicable to employees of similar categories under the Andaman and Nicobar Administration.
12. They are directed to report for duty to their respective place of posting within 30 days from the date of issue of appointment order, failing which their appointment will be treated as cancelled.
13. No TA/DA will be admissible or allowed for their joining the post on appointment.
