

NOTICE**Allotment of B.Ed Course in Bhopal**



Applications are invited from eligible candidates of Andaman & Nicobar Islands in the prescribed form for admission in the Institute of Advanced Study in Education (Govt. College of Education), Berasia Road, Bhopal for the year 2010-2011 against 15(Fifteen) seats in B.Ed. course.

ELIGIBILITY CRITERIA

- (i) Eligibility requirements for admission to the above course have not been communicated by the Govt. College of Education, Bhopal. However, as per common requirement, the candidates should have passed B.A./B.Sc./M.Com examination from a recognized University and has offered subject relating to school education at the first or second-degree level. Relaxation for ST candidates of A & N Islands will operate as per norms.
- (ii) Candidates seeking admission should fall under any of the categories for reservation of seats as specified by the Government of India (Ministry of Home Affairs) vide order dated 30/5/1996.
- (iii) Equal preference will be given to the candidates who have taken degree from a local college as well as Mainland college subject to the condition that the candidates belong to one of the five categories laid down in the Govt. of India, Ministry of Home Affairs order No. U-14040/5/96/ANL dated 30/5/1996.
- (iv) Application without attested copies of pass certificate in the qualifying examination (Final or Provisional), Degree level mark statement, issued by the concerned University or local College authorities will not be entertained.
- (v) The Administration will not be responsible in case any candidature is rejected by the host Institute on account of change of eligibility criteria /requirement or policy or late reporting to the Institution. No nomination from this Administration will be issued for B.Ed course in Govt. College of Education, Bhopal in respect of candidates whose case has already been considered by the Govt. Tagore College of Education, Port Blair.
- (vi) The seats will be allotted only after getting confirmation from the Host Institution.

Applications complete in all respects should reach the Development-IV Section of the Secretariat, Port Blair **on or before 14th June, 2010** during working hours. Incomplete applications will not be considered.

ALLOTMENT OF PROFESSIONAL/ TECHNICAL & NON-TECHNICAL COURSES

Applications are invited from the Malayalee /Tamil Origin candidates settled in A & N Islands in the prescribed form for allotment of the following seats which are usually reserved for them every year by the Government of Kerala/Tamil Nadu, for nomination during the current academic session 2010-11. Names of discipline and number of seats specified hereunder are provisional and are based on last year's allocation.

Sl. No.	Name of the course	No. of seats	Eligibility criteria
1.	M.B.B.S (Malayalee Origin)	01	Candidates, who have passed pre-degree or any other examination recognized by the Universities in Kerala State as equivalent thereto with 50% marks in biology separately and 50% marks in Physics, Chemistry and Biology put together, are eligible.
2.	B.A.M.S (Malayalee Origin)	01	
3.	B.Sc (Agri) (Malayalee Origin)	01	
4.	M.V.Sc (Tamil Origin)	01	Candidates with B.V.Sc Degree of Tamil Nadu Veterinary and Animal Science University (OR) any other Degree recognized as equivalent.
5.	M.F.Sc (Tamil Origin)	01	Candidates with B.F.Sc Degree of Tamil Nadu Veterinary and Animal Science University (OR) any other Degree recognized as equivalent.

The Malayalee/Tamil Origin candidates, whose parent have settled in A & N Islands permanently can apply for the above seats, provided such candidates have a minimum of 10 years continuous education in these Islands. Applicants are required to submit the filled in application form alongwith attested copies of Xth and XIIth class Pass Certificates, Statement of marks, Birth Certificates, Migration Certificates, Duration Certificate and the certificate to the effect that he/she is of Tamil/ Malayalee Origin settled in these Islands, from the Revenue Authority not below the rank of Tehsildar, certificate of 10 years continuous education in these Islands from the Head of Institutions where the candidates studied for last 10 years and the local certificate from the Revenue Authority, and submit the same to the Education Section (Dev-IV) of the Secretariat, Port Blair by **21st June, 2010 upto 3.00 p.m.**


Nominations will be issued only after getting the confirmation from the concerned State Governments about reservation of above seats during the current academic year 2010-11.

The Administration will not be responsible, in case any candidature is rejected by the State Institution/Colleges on account of change in eligibility criteria/ requirement or policy or late reporting to the Institutions.

For determination of merit, the practical marks will not be taken into account for the courses mentioned at Sl. No. 1-3. However, both the theory and practical marks will be shown in the nomination letter.

Application forms can be obtained from the Education Section (Dev-IV) of the Secretariat, Port Blair on payment of Rs.10/- (Rupees ten only) per form from **28th May, 2010 to 19th June, 2010** on all working days.


