Sub: Revival of vacant posts - Regarding.

Sir,

I am directed to refer to your d.o. letter No.45-397/2005-PW dated the 9th July, 2005 on the above cited subject and to say that it is observed that the Ministry of Finance (Department of Expenditure) had vide their OM No.7(19) E.Coord./94 dated 1st August, 1994 relaxed the economy instructions to the effect thet in so far as Lakshadweep and A&N Administration are concerned, the posts remaining vacant for two years or more will only be deemed to be abolished. A copy of the aforesaid OM of the Ministry of Finance is enclosed. It is, however, observed that the A&N Administration have included a number of such vacant posts as are lying vacant for less than two years in their list of vacant posts for which revival has been sought for by the A&N Administration. Since the posts lying vacant for less than two years are not to be treated as deemed abolished in case of A&N Administration, there is no question for their revival. The A&N Administration may straightaway fill up these posts.

2. You are, therefore, requested to kindly initiate process for filling up of all such posts as are lying vacant for less than two years in various Departments of the A&N Administration immediately. As regards the posts lying vacant for two years or more, the matter is being referred to Ministry of Finance through Integrated Finance Division of this Ministry for their approval to their revival.
