CIRCULAR

As you are aware, the DIGP (Int) and SDPOs/Dy SP (HQ) have been designated as Central Public Information Officer and Assistant Central Public Information Officer respectively vide IGP's order No. 3274 dated 21/09/2005 under 'Right to Information Act 2005', in terms of sub-section (1) & (2) of section 5.

Considering the need for explicit indication of the appellate authority under A&N police department, the IGP, A&N Islands has been specifically designated as the appellate authority for the A&N Police department.


