
PRESS NOTE

On the basis of select list of 302 Lower Grade Clerk/Lower Division Clerk under A&N Administration published on 16/01/2017, offer of appointment were issued on-line to all selected candidates on 17/01/2017, of which 292 candidates have accepted the offer and submitted their willingness. Posting of all the candidates has been finalized as per software for randomization developed by NIC. The final list of posting of 278 candidates assigned to the Amalgamated Clerical Cadre by the randomization software developed by NIC has been displayed on the Notice Boards of the Secretariat and can also be downloaded from the website [www.and.nic.in](http://www.and.nic.in).

Appointment orders have been dispatched to all concerned. However, a hard copy can also be taken by the concerned candidate from the Personnel Section in Secretariat from 12/02/2017 to 17/02/2017 from 10.00 a.m. to 5.00 p.m. on production of valid ID Proof (Sunday Open). The posting orders of remaining 14 candidates assigned to the CPAO by the randomization software developed by the NIC shall be issued by the office of CPAO separately.

Two days Induction Training Programme for all the 292 candidates has been organized on 14<sup>th</sup> & 15<sup>th</sup> February, 2017 at the Auditorium of Tagore Govt. College of Education, Middle Point, Port Blair in order to familiarize them with the nature of duties and responsibilities of Clerical Cadre and to impart basic knowledge about the Central Civil Services Rules/General Financial Rules. The training programme will be inaugurated by the Chief Secretary, A&N Administration.

All the candidates are required to attend the training programme at the Auditorium of Tagore Govt. College of Education, Middle Point, Port Blair at 08.30 AM on 14<sup>th</sup> & 15<sup>th</sup> February 2017.


