**PRESS NOTE**

**Revised date of Spot Round counselling of CSAB NEUT-2017**

In continuation to the Administration's press release published in The Daily Telegram on 04.08.2017, it is brought to the notice of all concerned candidates of A&N Islands that the Supernumerary round of counselling for allotment of NIT seats for UTs of Andaman & Nicobar Islands, Dadar & Nagar Haveli, Daman & Diu, Lakshadweep and Kandvi has been revised and scheduled to be held from 5<sup>th</sup> August to 8<sup>th</sup> August, 2017 (5.00PM).

Due to clash of dates for Supernumerary round of counselling for NIT seats and Spot round of counselling of CSAB NEUT-2017 for B.E/B.Tech/B.Architecture/B.Pharmacy seats and in order to avert surrender of seats and maximum utilization of above seats by the students of A&N Islands, it is informed that the **Spot Round counselling of CSAB NEUT-2017 will be conducted on 10.08.2017 from 10.00 am onwards instead of 08.08.2017 at the Auditorium of JNRM, Port Blair.**

It is further advised to all eligible candidates who were registered in CSAB NEUT-2017 (whether allotted seat in 1<sup>st</sup>/2<sup>nd</sup> round or not) and interested for participation in Spot Round counseling are requested to do their choice filling afresh in the CSAB website. Although it is not mandatory for students who have been allotted a seat in round 1 or 2 to participate in spot round.

Those candidates who are already allotted a seat in Engg/Arch in 1<sup>st</sup>/2<sup>nd</sup> round will have an option of retaining the present allotment. However, if they fill the choices and a seat is allotted in the Spot round to such candidates, the earlier allotted seat (round 1 or 2) will automatically stand cancelled.

The schedule of registration and choice filling of Spot Round counselling of CSAB NEUT-2017 and other details as mentioned in earlier press release dated 04.08.2017 will be same.
