


NOTICE

It is brought to the notice that in response to this Administration's Notice published in the Daily Telegrams dated 06.07.2008, the claims and objections received in context to the Provisional Merit List for admission/allotment of seats in Professional/Technical/Non-Technical courses at various institutions at mainland have been examined and it has been held that the cases of Ms.Susmita Sinha, D/o Shri Bimal Sinha, registration No. 156 appearing in Provisional Merit List under category-IV and Mr Preetam Gupta, S/o Sunil Kumar Gupta, registration No. 530 appearing under category-II do not cover in the aforesaid categories in which they have applied. As per the report received from the Chief Engineer & Administrator, Andaman & Lakshadweep Harbour Works, Port Blair, Shri Bimal Sinha, F/o Ms Susmita Sinha is a Central Govt. employee having all India transfer liability. And therefore, it revealed that Ms Susmita Sinha does not fall under Category-IV. Thus the claim of Ms.Susmita Sinha, D/o Shri Bimal Sinha, Registration No. 156 for allotment of seat under Category-IV cannot be acceded to.

Further on verification of documents submitted by Mr. Preetam Gupta, S/o Sunil Kumar Gupta, registration No. 530, it has been found that he has not studied in these Islands for the last two years and therefore the claim of Mr. Preetam Gupta for allotment of seat under Category-II cannot be acceded to.

It is therefore brought to the notice of all concerned that the claims of Ms.Susmita Sinha, D/o Shri Bimal Sinha, registration No. 156 for allotment of seat under Category-IV and Mr. Preetam Gupta, S/o Sunil Kumar Gupta for allotment of seat under Category-II & V are rejected and their names will be deleted from the Final Merit List from Category-IV and Category-II & V respectively, which will be published in due course for admission/allotment of seats in Professional/Technical/Non-Technical courses at various institutions at mainland. However the name of Ms.Susmita Sinha, D/o Shri Bimal Sinha will remain under Category-V in the Final Merit List.


